SUBJECT: **Report on the City Selection Committee Appointments**

DISCUSSION

The City Selection Committee, comprised of the Mayors or designed Council Member of the each of the eight cities in Santa Barbara County, met on October 20th to appoint or replace Regular voting member Etta Waterfield, Santa Maria City Council Member, whose term expires on March 1, 2023. The selected member to fulfill the remaining term and then be extended until 2027 by the Selection Committee was Alice Patino, Santa Maria City Council Mayor. Mrs. Waterfield Council seat ends in 2022.

The City Selection Committee also selected Janelle Osborne, Lompoc City Council Mayor, to fulfill the Alternate City member, currently held by Buellton Mayor Holly Sierra, who will no longer hold a Council seat ending in 2022. This term expires on March 1, 2024. **Attachment A.**

The City Selection Committee will need to meet again to appoint one Regular member to LAFCO for the remaining term of Commissioner Roger Aceves. The Regular City member was not re-elected. This term expires on March 1, 2024. This meeting has not been scheduled as of yet. The Alternate City member will sit on the Commission until a replacement is selected. If the current Alternate City Member is appointed, the City Selection Committee will make a second appointment to complete the unexpired term of the Alternate that expires on March 1, 2023.
