### DISCUSSION

The 60-day voting period for the election of Regular Special District Member between two candidates', ended on April 11, 2022 at 5:00 pm.

There was a total of 20 eligible independent special districts that filed ballots before the deadline expired.

The April 12, 2022, Notice of Election Results to Special Districts is attached as **Attachment A**. Votes cast by Special District is attached as **Attachment B**.

The results are as follows:

<b>Jay Freeman, Isla Vista Community Services District</b>	<b>13 Votes</b>
<b>Edward Fuller, Goleta Sanitary District</b>	<b>7 Votes</b>

By virtue of receiving the majority of the votes cast, Mr. Freeman was elected as a Regular Special District member of the Commission with a term to expire on March 1, 2026.

There was a total of 21 eligible Independent Special Districts that filed ballots by the deadline. The Alternate Nomination and Election Procedures reach a total of 20 eligible votes.

**17 Votes**      **Yes**

**3 Votes**      **No**

By virtue of receiving the majority of the votes cast, Mr. Freeman was elected as a Regular Special District Member of the Commission with a term to expire on March 1, 2026 and Alternate Nomination and Election Procedures received enough “yes” votes to hold future Nominations and Elections by mailed ballot procedures, forgoing the Independent Special District Selection Committee meeting.
