Assembly Bill 361 Determination

Pursuant to Government Code § 54953(e)(1), consider determination that 1) local health officials recommend social distancing to reduce transmission of COVID-19 and 2) as a result of the declared pandemic emergency, requiring in-person attendance at Commission hearings presents an imminent risk to the health and safety of attendees and, therefore, Commission meetings may be held via teleconferencing pursuant to Government Code § 54953(e)(2).

Changes of Organization

- 1) Consider approval of LAFCO application File No. 22-01 for the 1351 Holiday Hill sphere of influence amendment and annexation to Goleta Sanitary District (Annexation No. 385). Adoption of a Resolution includes the following actions:
 - a. Find the proposal to be exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15303 Class 3 New Construction or Conversion of Small Structures and 15319(b), Class 19 Annexation of Individual Small Parcels for Facilities Exempt by Section 15303;

- b. Amend the Spheres of Influence of the annexing agency to include 1351 Holiday Hill;
- c. Condition approval upon the annexed territory being liable for any existing indebtedness and authorized taxes, charges, fees and assessments of the Goleta Sanitary District;
- d. Find the subject territory is uninhabited; all affected landowners have given written consent and the annexing agency has given written consent to the waiver of conducting authority proceedings; and;
- e. Waive the conducting authority proceedings and direct the staff to complete the proceeding.

- 1) Consider 60-day notice of termination by the County of Santa Barbara regarding the LAFCO agreement for clerk services, dated May 20, 2014.

Information Items

- 1) Receive and file a status report from the Los Olivos CSD regarding the wastewater treatment project.
- 2) Receive a briefing on SB 1100 that amends the Brown Act to authorize a presiding member of a legislative body to order removed an individual who "actually disrupts" a legislative meeting.
- 3) Report on the 2022 CALAFCO Annual Conference in Newport Beach from October 19 through 21, 2022 regarding Speaker Biographies and Session Summaries.
- 4) Receive and file a status report on the Municipal Service Review Program.
