**NOTICE IS HEREBY GIVEN** that a meeting of the Santa Barbara Local Agency Formation Commission will be held on **Thursday, September 3, 2020, at 1:00 PM** by virtual participation only.

<u>Disclosure of Campaign Contributions</u> – LAFCO Commissioners are disqualified and are not able to participate in proceedings involving an "entitlement for use" if, within the 12 months preceding the LAFCO decision, the Commissioner received more than \$250 in campaign contributions from the applicant, an agent of the applicant or an financially interested person who actively supports or opposes the LAFCO decision on this matter.

Those who have made such contributions are required to disclose that fact for the official record of the proceedings. Disclosures must include the amount of the contribution and the recipient Commissioner and may be made either in writing to the Executive Officer of the Commission prior to the hearing or by an oral declaration at the time of the hearing.

The foregoing requirements are set forth in the Political Reform Act of 1974, specifically in Government Code section 84308.



#### **Changes of Organization**

- Consider recommendations regarding LAFCO File No. 20-01 for the 4 Sunrise Hill Lane expansion of the Sphere of Influence and Out-of-Agency Service Agreement for City of Santa Barbara to provide water and sewer services to an undeveloped residential parcel. The Commission will consider adoption of a Resolution that will take the following actions: (Continued from the August 6, 2020 meeting)
  - a) Find the project is exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15303(a) new construction of a single-family residence or second dwelling in a residential zone; Section 15320 change in organization of local agencies; and Section 15061(b)(3) the "common sense" exemption;
  - b) Amend the City of Santa Barbara's Sphere of Influence to include the 3.94 acre property (APN 013-210-049) located at 4 Sunrise Hill Lane within the City's sphere; and
  - c) Approve an Out-of-Agency Service Agreement that will authorize the City to provide water and sewer services to the property, subject to the terms and conditions in the Resolution.

- 2) Consider recommendations regarding LAFCO File No. 19-07 for the Judith Little Annexation to the Montecito Sanitation District, 5.68 acre property at 720 E. Mountain Drive, APN 013-040-031. The Commission will consider adoption of a Resolution that will take the following actions:
  - a) Find the project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15319 Annexation of Existing Facilities and Lots for Exempt Facilities;
  - b) Find that the territory is uninhabited, all affected landowners have given consent to the annexation and the District has consented to waive the conducting authority proceedings;
  - c) Waive the conducting authority proceedings; and
  - d) Approve the Annexation of Judith Little Annexation of a 5.68 acre parcel located at 720 E. Mountain Drive, Montecito, CA, to the Montecito Sanitation District in order to provide sewer services, subject to the conditions specified in the Resolution.
