## Board of Supervisors Hearing Room Santa Barbara CA

- 1. Chair Dick DeWees called the meeting to order at 2:00 p.m. Present were Commissioners DeWees, Fox, Orach, Umenhofer and Urbanske, Alternate Commissioners Andrisek, Rogers and Rose, Executive Officer Bob Braitman and Legal Counsel Alan Seltzer. Alternate Commissioner Leich participated by remote connection from Santa Maria.
- 2. The Pledge of Allegiance was recited.
- 3. Upon motion by Umenhofer, second by Fox, the August 1, 2002 minutes were approved, with Commissioners Rose and Urbanske abstaining.
- 4. Kevin Walsh, on behalf of the Goleta Water District, expressed a desire that LAFCO reconsider the detachment from the Goleta Water District approved on August 1 as part of the St. Vincent's Reorganization.
- 5.  $\underline{02-4}$  Out of Agency Service Agreement City of Santa Maria (Orcutt Apartments)

Public testimony was provided by Gordon Gill, representing the property owner, and Diane Dostolek, representing the City of Santa Maria.

After due consideration, upon motion by Urbanske, second by Orach, the Commission authorized the City of Santa Maria to provide water service subject to the recommended terms and conditions.

6. <u>02-12</u> – Out of Agency Service Agreement - City of Santa Barbara (Schechter)

After due consideration, upon motion by Rogers, second by Orach, the Commission authorized the City of Santa Barbara to provide sewer service subject to the recommended terms and conditions.

Commissioner Rose requested that in the future information be provided showing existing outof-agency service agreements in the vicinity of the proposal.

7. Commission Policies Regarding Reimbursement of Expenses

Interested citizen Ken Taylor spoke.

The Commission continued this matter until the October 10 meeting.
