Status of Approved Proposals

Cavaletto Annexation to Goleta Sanitary District (LAFCO 12-5) was approved September 6. We can record the annexation when authorized to do so by the Goleta Sanitary District.

Palmer Annexation to Goleta Sanitary District (LAFCO 12-6) was approved November 1. We can record the annexation when authorized to do so by the Goleta Sanitary District.
