Those who have made such contributions are required to disclose that fact for the official record of the proceedings. Disclosures must include the amount of the contribution and the recipient Commissioner and may be made either in writing to the Executive Officer of the Commission prior to the hearing or by an oral declaration at the time of the hearing.

The foregoing requirements are set forth in the Political Reform Act of 1974, specifically in Government Code section 84308.

# STAFF REQUESTS THE CONTINUANCE OF CHANGE OF ORGANIZATION ITEM NO. 1 TO SEPTEMBER 3, 2020

1) Consider recommendations regarding LAFCO File No. 20-01 for the Out-of-Agency Service Agreement & Sphere of Influence Amendment – 4 Sunrise Hill Lane and consider approval of application for expansion of Sphere of Influence and Out of Agency Service Agreement for the City of Santa Barbara to provide water and sewer services to an undeveloped residential parcel. The Commission will consider adoption of a Resolution that will take the following actions:

- a) Find the project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303(a) new construction of a single-family residence or second dwelling in a residential zone; Section 15320 change in organization of local agencies; and Section 15061(b)(3) the "common sense" exemption;
- b) Amend the City of Santa Barbara's Sphere of Influence to include the 3.94 acre property (APN 013-210-049) located at 4 Sunrise Hill Lane within the City's sphere; and
- c) Approve an Out-of-Agency Service Agreement that will authorize the City to provide water and sewer services to the property, subject to the terms and conditions in the Resolution.
- 2) Consider recommendations regarding LAFCO File No. 19-06 for the Sienna Way Annexation to the Santa Ynez Community Services District. The Commission will consider adoption of a Resolution that will take the following actions:
  - a) Find the project is exempt from the California Environment Quality Act (CEQA) pursuant to CEQA Guidelines section 15319 Annexation of Existing Facilities and Lots for Exempt Facilities;
  - b) Find that the territory is uninhabited, all affected landowners have given consent to the annexation and the District has consented to waive the conducting authority proceedings;
  - c) Waive the conducting authority proceedings; and
  - d) Approve the Annexation of 3 developed parcels located at 837, 843, and 846 Sienna Way, Santa Ynez, California, to the Santa Ynez Community Services District in order to provide sewer services, subject to the conditions specified in the Resolution.
