 - Seymour - approximately one acre located north of and including Santa Ynez Avenue, about 600 feet east of Refugio Road (3077 Santa Ynez Avenue).

8. 00-10 –Investec Reorganization: Annexation to the City of Santa Barbara/Detachment from the Santa Barbara County Fire Protection District/Detachment from the Goleta Water District; approximately 1.5 acres located east of and adjacent to Hope Avenue, at its intersection with Calle Cita (588 North Hope Avenue).
