SUBJECT: LAFCO Project and Activity Update

This is an informational report. No action is necessary.

This is a periodic report of LAFCO staff activities. The last report was on April 23, 2012.

Status of Approved Proposals

The Jewkes Annexation to the Goleta Sanitary District (LAFCO 12-2) was approved on May 3, 2012; we are waiting for expiration of the 30-day waiting period in order to record this boundary change.

The Doherty Annexation to the Santa Ynez Community Services District (LAFCO 11-6) was approved on August 4, 2011 and was recorded on April 23, 2012. We received a statement from the State Board of Equalization that the annexation will appear on the 2013-14 assessment roll.

The Lee Out-of-Agency Service Agreement for the City of Goleta (LAFCO 10-7) was approved by the Chair on December 14, 2010; the property is not yet connected, perhaps due to an ownership change

Status of Pending Proposals

It appears the Commission may be able to consider the following items at its next meeting which will be on July 5 in Santa Barbara.

- Hope Avenue Reorganization: Annexation to the City of Santa Barbara and detachments from County Fire Protection District, Goleta Water District and County Service Area 32 (LAFCO 12-3).
- Silverman et al expansion of the Goleta Sanitary District Sphere of Influence

LAFCO Staff Activities

- 5. On May 18 staff participated in a CALAFCO Legislative Committee meeting that was conducted as a conference call.
- 6. The next Commission meeting will be held on Thursday, June 7 in Santa Maria.
