**Consider Amending the 2020 Santa Barbara LAFCO Schedule of Meeting Dates and Locations**

Dear Members of the Commission:

RECOMMENDATION

It is recommended that the Commission amend the 2020 Schedule of Meeting Dates and Locations for the June 2020 Regular Meeting date.

DISCUSSION:

The Commission will hold a special meeting on Thursday, May 14, 2020, to consider approval of the proposed budget for Fiscal Year (FY) 2020-2021. Government Code section 56381(a) directs the proposed budget be adopted no later than May 1<sup>st</sup> and the final budget no later than June 15<sup>th</sup>. The proposed budget was originally scheduled for the March LAFCO meeting but was cancelled because of concerns about the pandemic. Later, the May 4, 2020 hearing could not proceed as planned due to staff illness. Therefore, adoption of the proposed budget is therefore proposed for May 14, 2020, however, this is two weeks later than called for in the statute.

While the Commission is currently scheduled to meet on Thursday, June 4, 2020 to adopt the final budget for FY 2020-2021, the concern is that with the delay of the proposed budget, this schedule does not give the County, Cities, and Special Districts as much time as they would like for review. The Commission is asked to consider a later date for final adoption, preferably on or before June 15<sup>th</sup>.


