SPHERE OF INFLUENCE AMENDMENT FOR THE LAGUNA COUNTY SANITATION DISTRICT (NORTH COUNTY JAIL SITE)

NOTICE IS HEREBY GIVEN that a meeting of the Santa Barbara Local Agency Formation Commission will be held on **Thursday, September 4, 2014 at 1:00 p.m.** at the Joseph Centeno Betteravia Government Administration Building, Board Hearing Room, 511 East Lakeview Parkway, Santa Maria, California, Board of Supervisors Hearing Room, California to consider a Proposed Amendment to the Sphere of Influence for the Laguna County Sanitation District (North County Jail Site).

<u>Location and Project</u> – The area proposed to be included in the sphere of influence is a 50 acre parcel on the southwest corner of the intersection of Betteravia Road and Black Road. The purpose of the sphere of influence amendment is to allow annex to the Laguna County Sanitation District so that sewer services can be extended to the site of the proposed Santa Barbara County North County Jail.

<u>Remote Testimony is Permitted</u> - Persons may address the Commission in person or by using the remote video testimony system at the Board of Supervisors Hearing Room located at 105 East Anapamu Street, Fourth Floor, Santa Barbara.

<u>Disclosure of Campaign Contributions</u> – LAFCO Commissioners are disqualified and are not able to participate in proceedings involving an "entitlement for use" if, within the 12 months preceding the LAFCO decision, the Commissioner received more than \$250 in campaign contributions from the applicant, an agent of the applicant or an financially interested person who actively supports or opposes the LAFCO decision on this matter.

Those who have made such contributions are required to disclose that fact for the official record of the proceedings. Disclosures must include the amount of the contribution and the recipient Commissioner and may be made either in writing to the Executive Officer of the Commission prior to the hearing or by an oral declaration at the time of the hearing.

The foregoing requirements are set forth in the Political Reform Act of 1974, specifically in Government Code section 84308.
