DISCUSSION

The CALAFCO Legislative Committee convened a meeting on February 19, 2025. Your Executive Officer participated in the meeting by ZOOM. A copy of the Meeting Agenda is attached as **Attachment A**.

Four legislative proposals were considered and discussed. These included CKH 57002 for noticing a conducting authority, Government Code Section 37396(b), Section 56044 that defines Independent special districts, Government Code Section 57002 refers to noticing requirements, and Government Code Sections 56021(m), 56824.10, 56824.12, and 56824.14 refer to "new or different functions or classes of services" provided by a special district. Some of these may be included in the annual Omnibus bill. The period to add proposals was closed for now.
