Remote Testimony is Permitted - Persons may address the Commission in person or by using the remote video testimony system located at the Betteravia Center, Board Hearing Room, 511 East Lakeside Parkway, Santa Maria.

Disclosure of Campaign Contributions – LAFCO Commissioners are disqualified and are not able to participate in proceedings involving an “entitlement for use” if, within the 12 months preceding the LAFCO decisions, the Commissioner received more than \$250 in campaign contributions from the applicant, an agent of the applicant or an financially interested person who actively supports or opposes the LAFCO decision on this matter.

Those who have made such contributions are required to disclose that fact for the official record of the proceedings. Disclosures must include the amount of the contribution and the recipient Commissioner and may be made either in writing to the Executive Officer of the Commission prior to the hearing or by an oral declaration at the time of the hearing.

The foregoing requirements are set forth in the Political Reform Act of 1974, specifically in Government Code section 84308.

### PROPOSED SPHERE OF INFLUENCE

It is proposed to adopt the Sphere of Influence of the City of Goleta consisting of approximately 5,937 acres (9.28 sq. mil.) in four components:

- Existing incorporated area – approximately 5,075 acres consisting of the territory within the existing City of Goleta boundaries
- Area A (Portion of South Patterson Agricultural Block) – approximately 85 acres located south of Hollister Avenue and east of State Route 217.
- Area C (North Fairview Avenue Area) - approximately 616 acres located east and west of Fairview Avenue, north of and adjacent to La Goleta Road.
- Area E (Glen Annie Golf Course) - approximately 161 acres located north of and adjacent to Cathedral Oaks Road, west of and adjacent to Glen Annie Road, consisting of the Glen Annie Golf Course.

Consideration will also be given to including 17.23 additional acres within the Sphere of Influence in conjunction with Area E and consisting of following three Assessor Parcels:

- APN 077-530-027 (David and Gail Lee) – 13.66 acres
- APN 077-530-029 (David and Gail Lee) – 2.56 acres
- APN 077-530-032 (Mark and Caroline Abate) – 1.01 acres
