Changes of Organization/Reorganizations

- 1) Consider LAFCO Application 15-2 for the Blickley Annexation, located at 1310 San Antonio Creek Road and 1200 San Antonio Creek Road, to the Goleta Sanitary District, proposing adoption of a Resolution that will take the following actions:
 - a) Certify your Commission has reviewed and considered the information contained in the Final Mitigated Negative Declaration for the Blickley Lot Split, State Clearing House No. 2014061038, dated July 14, 2014, prepared and approved by the County of Santa Barbara, as lead agency;
 - b) Approve the Expansion of the Sphere of Influence of the Goleta Sanitary District;
 - c) Approve the proposal known as the Blickley Annexation, subject to the conditions in the Resolution, including that the territory shall be liable for any existing or authorized taxes, charges, fees or assessments comparable to properties presently within the District;

- d) Find the subject territory is uninhabited, all affected landowners have given written consent and the annexing agency has given written consent to the waiver of conducting authority proceedings; and
- e) Waive the conducting authority proceedings and direct staff to complete the proceeding.
