## DISCUSSION

The 60-day voting period for the runoff election between the two candidates receiving the highest number of votes for the Regular Special District Member election, ended on August 5, 2019 at 5:00 pm.

There was a total of 32 eligible independent special districts that filed ballots before the deadline expired.

The results are as follows:

<b>Jay Freeman, Isla Vista Community Services District</b>	<b>18 Votes</b>
<b>Judith Ishkanian, Montecito Fire Protection District</b>	<b>14 Votes</b>

By virtue of receiving the majority of the votes cast, Mr. Freeman was elected as a Regular Special District member of the Commission with a term to expire on March 1, 2022.
